Eligibility Criteria:

- 1) The applicant should have a registered firm and well established workshop centre in state of Chhattisgarh.
- 2) Applicants who are/were providing the same type of services (fabrication and modification/customization) in any other organizations / Public Sector Banks /Private Banks for the same services will be preferred.
- 3) The applicant should not have been black listed / barred by any of the Government Departments / PSU's / Public Sector Banks / Private Banks during the last three years. An undertaking for the same is to be submitted by the applicant (**Annexure-VI**).
- 4) The applicant should be an Income Tax assesses and should possess a valid PAN in the name of Company/Firm.
- 5) The applicant should be registered with GST department and have a valid regular GSTIN.
- 6) The applicant firm should be a profit making firm in the last three years with an average annual high turnover (₹.Ten Lakh and above). Copies of the Audited Balance sheet for the last three years (2017-18, 2018-19 & 2019-20) should be submitted along with application.
- 7) Applicant must submit copies of documentary proof like GST Registration, Registration of Firm, PAN Card of Firm/ PAN Card of the Proprietor in the case of the Proprietorship Firm, Last 3 year ITR (Form-16) of Firm or Proprietor as the case may be, KYC of the owner/s, Office address proof, Work Order / Contract. Successful work completion certificates if any for doing fabrication work for other organization, Undertaking etc. so as to satisfy all the eligibility criteria.
- 8) Previous work details of similar type of work done should be mandatory mentioned with details and proof to be submitted. Product brochures of the items which will be fitted at the time of modification and technical literature should invariably also is attached with technical bid.
- 9) Applicant must submit their company profile mentioning their quality policy, specialist manpower strength with their past work experience, current assignment/services being provided to company/banks etc.
- 10) Earnest Money Deposit (EMD) of ₹ 50,000.00 (₹ Fifty Thousand Only) also to be submitted in favor of "**Chhattisgarh Rajya Gramin Bank**" Payable at Raipur along with offer/application. EMD shall not carry interest and retained by the bank during the warranty period i.e. one year after handing over the vehicle to the bank. EMD of unsuccessful bidders will be returned after finalization of tender process.
- 11) Vendor should have the fabrication and modification facilities at their workshop. Apart from that they should also have the following facilities at their work shop to complete the job as per our satisfaction:-
 - i. Vendor should have the proper fencing in their workshop premises so that any loss damage and theft may be avoided and proper parking facility to park bank vehicle at work shop should be there for fabrication work.

- ii. Vendor should also have the basic facility like welding machine, cutting machine and spray painting machine at their workshop. If any vendor do not have this facilities at their workshop will be disqualified.
- iii. Vendor should also submit their workshop photographs along with tender for confirmation of above facilities.

GENERAL TERMS AND CONDITIONS

1. No tenders shall be accepted after the stipulated date and time. Bank reserves the right to accept or reject the entire quotation, without assigning any reason thereof at any stage.
2. Any Bid received after the deadline (time period) for submission of Bids prescribed, will be rejected and returned unopened to the bidder.
3. Necessary documents should be attached with offer /quotation.
4. Validity: Rates quoted shall be valid up to 6 months. In exceptional circumstances, the Bank may solicit the Bidders' consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. The Bank reserves the right to call for fresh quotes any time during the validity period, if considered necessary.
5. A Bid valid for a shorter period may be rejected by the Bank as non-responsive.
6. Fabrication/Modification/Customization of Force Tempo Traveller Delivery Van to Mobile ATM VAN Vehicle requirement shown in Annexure-V and it may vary at the discretion of CRGB.
7. The "Financial Bid" should contain competitive prices should be mentioned in Annexure-V.
8. Prices to be quoted must be inclusive of ONE year warranty period. Prices shall be inclusive of all taxes and duties. Please indicate the rate taxes separately and it may be payable / applicable as per Govt norms.
9. Fabrication/Modification/Customization of Force Tempo Traveller Delivery Van to Mobile VAN ATM Vehicle Order will be placed in phased manner. On Completion of the Fabrication/Modification/Customization of the vehicle, Pre Receipt Inspection will be carried out at vendor workshop by Chhattisgarh Rajya Gramin Bank staff before taking delivery. Delivery of the vehicle after job completion shall be made as per work order completion date. Any delay will be penalized @2% of the order value per week of delay or part thereof. Amount of penalty so calculated will be deducted at the time of making final payment.
10. The rates quoted once will be treated as final. No alteration either in rates or in term & conditions will be entertained. Bank may have its own discretion to extend the deadline (time period) for submission of bids in order to enable bidders to prepare or submit the bids so that competitive / lowest rate should be received with better quality.
11. The successful bidder(s) to whom the work is awarded will be under direct liaison of the representative of CRGB, Head Office, Raipur and has to follow his instructions from time to time.

12. In case of any dispute, decision of CRGB authority shall be final and abiding to the vendor.

13. Bank reserves the right to accept the offer of only one vendor in full or more than one vendor in part or reject any or all quotations, without assigning any reason thereof and irrespective of L1 criteria, at any stage.

14. The bidder(s) will not be permitted to assign or give sub contract of the work awarded to him without prior permission from CRGB authority. The decision of CRGB authorities in this regard shall be final and binding to the vendors/bidders.

15. The vendor(s) must meet necessary statutory and legal compliances. CRGB will not be responsible for any legal action arising out of non-compliance to statutory & other similar legal compliances.

16. Any loss or damage caused during fabrication/modification work to the CRGB property (VAN) by the personnel deputed by the vendor will be recovered from payment of bill to the vendor and the decision of CRGB authority in this matter will be treated as final and abiding to the vendor.

17. Photocopy of Company Authorization / Dealer Certificate also to be attached with tender documents.

18. In case of withdrawal of proposal by successful bidders they will be liable for forfeiture of EMD. EMD amount will be forfeited in the event of the agency failure to observe any terms and conditions of this tender or noncompliance with the condition of contract.

19. **SUBMISSION OF BIDS-** Project Name "**Fabrication/Modification/Customization of Force Tempo Traveller Delivery Van to Mobile VAN ATM Vehicle for Chhattisgarh Rajya Gramin Bank**" All envelopes should indicate the name and address of the Bidder on the cover and clearly marked as "Technical Bid and Financial Bids". **Note: The tender documents should be submitted in original, duly signed and stamped at each page. Fax/telegram/telex will not be acceptable.**

20. **General Guidelines**

- a. During evaluation and comparison of bids, the Bank may, at its discretion ask the bidders for clarification of its bid. The request for clarification shall be in writing and no change in prices or substance of the bid shall be sought, offered or permitted. No post bid clarification at the initiative of the bidder shall be entertained.
- b. Before quoting price bid vendor may visit the Head Office of Chhattisgarh Rajya Gramin Bank, Mahadevghat Road, Sunder Nagar Raipur for seeking any clarification.
- c. Bank staff may visit to the (L-1) vendor workshop or their premises before giving modification (repair) order.

21. **Technical Evaluation of bids**

- a. The Technical Bid should be complete in all respects and contain all information required in the document. It should not contain any price information. Technical Bid should confirm that all required particulars have been quoted as per eligibility criteria.

b. It is mandatory to submit the technical details duly filled in along with the offer. In case of non- submission or partial submission of technical details, the Bank, at its discretion, may not evaluate the offer. The Technical Bid must be submitted in an organized and structured manner. No brochures / leaflets etc. should be submitted in loose form.

The Technical Bid should comprise of the following:-

- (i) Type of Fabrication work done at their workshop
- (ii) Technical Bid Parameters complete with all the photocopies of required certificates / documents/proof/P & L & Balance sheets, Copies of order executed etc.
- (iii) Declaration by the service provider (**Annexure-VI**).

22. Evaluation of Price Bids and Finalization

- a. Only those Bidders who qualify in pre-qualification and Technical evaluation would be shortlisted for commercial evaluation i.e. financial bids.
- b. The L1 Bidder will be selected on the basis of price evaluation as quoted. However, the Bank reserves the right to reject the L-1 bid if it's not fulfilling the Technical evaluation. The rates will be valid for the period of 180 days (06 months) from the date of opening of bids.
- c. The bidder is required to provide price breakup in **Annexure-V**

23. Payment Terms:

- a) No Advance Payment will be made for any fabrication/modification job order released.
- b) After satisfactory fabrication/modification work of mobile ATM VAN received by bank at respective sites 100% of Invoice amount will be paid within one week.
- c) No payment, however, will become due in case of any short supply of equipment, delay or damage during fitment/installation in mobile ATM VAN will not be accepted.
- d) The necessary TDS will be made as per Central Government norms.
- e) In case of failure on the part of the vendors to provide warranty / sustain repair or maintenance work to the Mobile ATM VAN vehicle as per satisfaction work of the Bank, CRGB authority reserves the right to forfeit the Earnest Money Deposit (EMD) amount as security deposit.
- f) Bills/Invoices should be detailed/annexed serial number, Part Number branch-wise separately mentioning SGST, CGST separately, although prices to be quoted inclusive of all taxes with breakup.

24. Delivery Schedule & Penalty for Delayed Deliveries

Please arrange to deliver the customized van within 30days from the date of receiving the vehicle from the company at your site/workshop. In case of delayed delivery penalty will be imposed at the rate of 2 % of contract value per week and the amount will be deducted at the time of making final payment to the vendor.

25. SERVICE SUPPORT INFRASTRUCTURE:

- a) The vendor should guarantee continued service in the form of Warranty for a period of at least 12 Months.
- b) Vendor will have to give an undertaking that a proper service/support will be provided by them during warranty period (Annexure-VII). If any items become unserviceable of the fabricated mobile ATM van than vendor has to provide the full support to make them serviceable. No extra payment will be paid by bank for this job.
- c) Complaints of repairing/fault will have to be solved within 72 hours of receipt. This lead-time for making the faulty system operational will include travel time of service personnel.

26. Bank has right to award the work order region specific to vendor having sound service support network in the region, if he match the L-1 prices.

27. Relaxation in any of the terms and conditions will not be given by the bank.

28. All legal disputes between the parties shall be subject to the exclusive jurisdiction of the Courts situated at Raipur.

Technical Specification for Fabrication/ Modification Work
Force Tempo Traveller Chassis to Mobile ATM VAN

1. To provide all necessary hardware required to make the fabrication/modification work strictly as per technical specification. The specifications given as minimum basic requirement.
2. Bidders can quote equivalent or higher technical specifications to meet the Bank's requirements. However no weightage would be given for higher configurations.
3. **Fabrication Work:** The Description of work for Force Tempo Traveler is Interior FRP Roof paneling, seamless, hygienic, easy clean and maintenance.
4. **Framework:** A MS structure frame work should be made as per our specification, above this frame work 3 mm thick Fire sheet should be fixed. 50 mm thermocol insulation for whole vehicle body including roof should be provided.
5. **Electrification:**
 - a. Necessary wiring, switches and points with concealed wiring should be done.
 - b. Inverter 1050 VA makes-Luminous Battery-120AH Make – Luminous.
 - c. Led Light and Led panel light
6. **Seating:** Work space including a table and chair for cashier and seating for officer (Chair) should be provided.
7. **Additional Fitting & Fixtures:**

The following additional fittings should be included:-

 - a. Coach Fans-3 Nos.
 - b. 2 Nos Small Fire Extinguisher 1 kg.
 - c. 43" Display Led TV, Make-Samsung Model-DB43 with speaker Make-Ahuja.
 - d. SS staircase and side door for ATM Machine.
 - e. Separate generator / Online UPS Chamber with door.
 - f. Awning/Canopy towards ATM/TV/Working window side.
 - g. Revolving Chairs (1 No.)
 - h. Collapsible Grill near rear door and Exterior MS grill on Sliding window.
 - i. CCTV Camera with DVR, Make-CP Plus (4Nos), with remote viewing facility.
 - j. 2 Speakers at roof ceiling connected to PA Amplifier system, Make-Ahuja.
 - k. A Vertical storage and an equipment rack above generator chamber.
 - l. A working table with drawers on the left side.
 - m. A steel box made of high grade / heavy gauge steel for carrying cash with top seating arrangement and proper locking system in the cash box for safety.
8. **Flooring:** Scratch proof, heavy duty aesthetically matching floor of 12mm Marine Ply wood should be provided above which a PVC vinyl carpet should be pasted.
