

SCOPE AND ELIGIBILITY CRITERIA FOR VENDORS AND SUPPLIERS

Scope:

The panel for Furniture and Electrical/Data cabling valid for the 31/03/2026.

Eligibility Criteria:

- 1) All vendors and suppliers who intend to apply for empanelment should have the experience of successfully completing similar work during the last 2 years ending 31.03.2025 similar work means supply of items mentioned in respective of both the category.
- 2) The applicant should be an Income Tax assessor and should possess a valid PAN number in the name of the Company/ Firm.
- 3) The applicant should also have registration with GST department with valid regular GST registration number.
- 4) The applicant will be given preference if they have registered firm and wellestablished offices in state of Chhattisgarh.
- 5) The applicant should be a profit-making firm in the last two years and must have experience of two years in similar work and the average Turn over in the last two years should be Rs. 25.00 Lakh and above. Copies of the Audited Balance Sheet for the last two years financial year (2022–23, 2023–24) should be provided along with an application form. Projected/Provisional Balance Sheet for the financial year 2024-25 may also be provided with the application.
- 6) If the applicant is empanelled with any other organizations/ departments/ PSU/ PSBs/ FIs they should enclose a copy of such empanelment. However, empanelment with another institution is not mandatory. Presently vendor empanelled with CRGB need not to submit their application.
- 7) The applicant should not have been blacklisted/ barred by any of the Government Departments/ PSU's/ Public Sector Banks/ Financial Institutions in the last two years. An undertaking on the same is to be provided by the applicant on their company/firm letter head (Declaration format is attached as Annexure).
- 8) Applicant must submit copies documentary proof of above requirements. Proof like relevant pages of registration, PAN card, GSTIN Certificate, Trade License, Office address proof, Office/firm Rent Agreement, Audited balance sheets, Work Order /Contract Successful completion certificates, KYC Documents, Undertaking etc. all to satisfy the eligibility criteria laid above.
- 9) The applicant has to deposit the application fee (nonrefundable) of **Rs. 1000.00** (Rupees One Thousand Only) by way of Demand Draft favoring "Chhattisgarh Rajya Gramin Bank" Payable at Raipur along with the application for each category. The application received without application fee will not be entertained and same will be rejected.



- 11)Application received after due date will not be accepted. If any Applicant is applying for one category, that will not be accepted by bank. Only those vendors who can execute both type of work (Furniture work and Electrical/Data cabling) can apply for both the Categories jointly can submit their application along with application fee (nonrefundable) of Rs. 1000.00 (Rupees One Thousand Only).
- 12) Those vendors who already registered with Chhattisgarh Rajya Gramin Bank for the category of Furniture work they can apply for Data Cabling/Electric Wiring and those vendors who already registered in Data Cabling/Electric Wiring category can also apply for Furniture work. Other than this, other Vendor has to apply for both the categories jointly.

GENERAL RULES AND INSTRUCTIONS TO THE INTENDING APPLICANTS

- 1. If vendor seek empanelment for both the categories jointly can submit their application. If vendor is applying for single category of work their application will not be accepted by bank.
- 2. Nonrefundable Application fee Rs. 1000.00 (Rupees One Thousand Only) should be paid in form of demand draft in favor of "Chhattisgarh Rajya Gramin Bank" payable at RAIPUR attached with application.
- 3. Selected applicant would have to deposit the security deposit amount as follows in the form of Demand Draft/PAY Order to the bank **for entire empanelment period i.e.**, **31-03-2026.** FD/STDR will also be accepted, and no interest will be paid on security deposits by the bank during the entire empanelment period. For both the Categories jointly, vendor has to submit security deposit is as follows : -


- 4. Generally, the routine works of the Bank are awarded by inviting competitive tenders / quotations from the empanelled vendors and suppliers, However, the Bank reserves the right to award the work to any of the empanelled Vendor/Suppliers <u>OR</u> opt for open tendering/quotation process for any items/ if anytime, deem fit.
- 5. The Bank will not be bound to accept the lowest tender and reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.
- 6. If L-1 Vendor denies/ fails to supply the items on time then the vendor will be debarred for further procurement process or delist from the empanelled vendor list. Bank decision will be final in this regard.
- 7. Cost incurred by the applicants in applying, in providing necessary clarifications or attending discussions or site visits will not be reimbursed by the Bank.
- 8. Documentary proof (like empanelment letter/ Work orders) regarding eligibility criteria shall be furnished along with the application form. Incomplete application or applications without proper proof for establishing their credentials will be summarily rejected and no correspondence will be entertained in this regard.
- 9. If the application is submitted by a partnership firm, the current address of the firm and full names and current address of all the partners of the firm shall furnish in the application.
- 10. If the application is made by a limited company, it should be signed by a duly authorized person and submit all supporting documents with application.
- 11. The evaluation will be made based on the experience of the vendors & suppliers and their financial capabilities. Decision of the Bank regarding selection/ rejection for empanelment will be final and binding and no further correspondence will be entertained.

- 12. If information and details furnished by the applicants are found to be false at any time in future or any information is withheld, which later on comes to the notice of the Bank, the empanelment of such applicant may be cancelled immediately.
- 13. Applications received after the due date and time/ not fulfilling the prescribed criteria are liable for rejection.
- 14. Each page of the application and submitted documents along with application shall be signed by person/s on behalf of the organization having necessary authorization/ Power of Attorney to do so.
- 15. If the space in the format is insufficient for furnishing full details, the information shall be supplemented on separate sheets of paper stating there in the part of the statement and serial number. Separate sheets shall be used for each part.
- 16. Vendors and suppliers preferably having their office in the geographical jurisdiction of the Bank or in the state of Chhattisgarh will be preferred. The empanelment will be valid till 31.03.2026 from the date of finalizing of the empanelment list. However, the empanelment will be subjected to quality of service and periodical review.
- 17. Vendors and suppliers should not indulge in unethical practices and should execute the work awarded to them as per the terms and conditions of the contract and specifications and should co-ordinate with the Bank officials.
- 18. Bank will select the vendor for empanelment on points-based system decided on eligibility criteria basis and other terms condition of the empanelment. The decision of the Bank in the selection of the vendor for empanelment will be final. The Bank is not bound to assign any reason therefor.
- 19. Vendors and suppliers should execute the work satisfactorily, on time, and with prescribed quality. Bank will have the right to debar/remove his name from the approved list of vendors and suppliers, after issue of a show cause notice if their services are not found satisfactorily & timely. Decision of the Bank will be final and binding.
- 20. All legal disputes between the parties shall be subject to the exclusive jurisdiction of the appropriate Courts situated at Raipur (Chhattisgarh).
- 21. Eligible vendors will be selected for empaneled and they have to enter in Pre contract agreement with bank.
- 22. Bank reserves the right to reject any / or all the applications without assigning any reasons whatsoever.
- 23. Chhattisgarh Rajya Gramin Bank reserves the right to add / remove in empanelment list if found that it in interest of Bank.
