- 4. EMD (refundable) ₹. 5000.00 (Rupees Five Thousand only) should be paid in form of demand draft/Pay Order in favor of **Chhattisgarh Rajya Gramin Bank** payable at RAIPUR along with each bid.
- 5. Chhattisgarh Rajya Gramin Bank reserves the right to add / change/ remove the condition/criteria if found that it is in interest of Bank.

- 12. The vehicle is sold on "As is where is" basis and "As is what is" basis. The bidder shall be deemed to have satisfied himself before submit their bid.
- 13. If the bid is accepted, the same will be intimated to the successful bidder. The EMD deposited by him/them shall be held as Security Deposit for due performance of the contract.
- 14. Successful bidder will be required to deposit the full amount of the tender less amount of EMD deposited along with bid within 7 days or on or before the date and time specified in the intimating letter and the bidder shall take delivery of vehicle.
- 15. Failure to deposit the balance within the time specified shall be construed as breach and the EMD will be forfeited without prejudice to Bank's right to claim damage for breach of contract and expenses of resale of the vehicle without further notice.
- 16. The DD for EMD amount will be refunded to the unsuccessful bidders without any interest thereon immediately against their acknowledgement.
- 17. Self attested KYC document viz. Address & ID proof shall be invariably submitted along with bid.
- 18. All expenses with regards to transfer of ownership of the vehicle/ RTO expenses will have to be borne by the successful bidder only.
