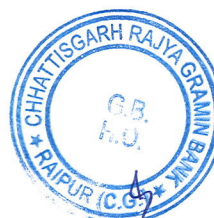


### **GENERAL RULES AND INSTRUCTIONS TO THE INTENDING BIDDERS**

2. If the bid is submitted by person other than individual, the details relating to constitution must be specified.
3. If the bid is submitted through Power of Attorney Holder or authorized representative, Proof of authorization should be enclosed.
4. Chhattisgarh Rajya Gramin Bank reserves the right to add / change/ remove the condition/criteria if found that it is in interest of Bank.
5. All legal disputes between the parties shall be subject to the exclusive jurisdiction of the Courts situated at RAIPUR.
6. Separate bid form to be submitted for specified items.

10. Bid received after stipulated time will be summarily rejected.
11. The material is sold on "As is where is" basis and "As is what is" basis. The bidder shall be deemed to have satisfied himself before submit their bid.
12. If the bid is accepted, the same will be intimated to the successful bidder.
13. Successful bidder will be required to deposit the full amount of the tender within 7 days or on or before the date and time specified in the intimating letter and the bidder shall take delivery of items.
